We distributed face masks and hand sanitizers for poor people and their family in our rural area and also in different states where our volunteer team was supporting poor and needy.






# ACTIVITY AND AWARENESS PROGRAM AFTER LOCKDOWN






Not only support we gave awareness about social distancing and usage of hand wash practice. It is very important that funds are raised as early as possible to meet this partially fulfilled need.

### MEDICAL SUPPORT






"Cancer is a marathon- you can't look at the finish line. You take it moment by moment, sometimes breath by breath, other times step by step".

# "ANNAPURNA" FOOD CAMP




Our motto in life is 'If you think it, you can do it' and if we all apply that thought we can end hunger the world over.


